The Local CODIS Administrator is a key member of our team, responsible for ensuring the highest level of quality in our laboratory operations. The successful candidate will lead, manage, participate in, and be accountable for the CODIS operations of the forensic biology laboratory. They will administer and maintain the laboratory's CODIS network in accordance with state laws and NDIS operational procedures.

Duties and Responsibilities

In this role, the Local CODIS Administrator will ensure the quality and security of data stored in CODIS and review and disposition DNA profile matches according to established guidelines. Travel to external training will be required to gain understanding of emerging technologies and best practices.

This position involves scheduling and documenting CODIS training for section laboratory analysts

and conducting relevant training for local agencies. The Administrator will assist in formulating laboratory policy, develop section-specific procedures and training manuals, and monitor laboratory practices to verify continuing compliance with policies and procedures.

The incumbent will serve as the primary point of contact for CODIS-related inquiries and issues, perform routine backup of CODIS data, verify system integrity, and coordinate with other CODIS laboratories across the United States. They will be responsible for maintaining casework competency and technically reviewing casework to ensure that established laboratory procedures are used to form the basis for scientific conclusions.
